

Thank you for choosing Cruise Control Driving School

This letter and attachments will inform you of the process and requirements for your classroom instruction, driving instruction, your road test and obtaining your license. If you still have questions after reviewing all the materials, you may review our Frequently Asked Questions (FAQs) section on our website or you may call us at (843) 875-0930.

Please fill out your portion of the downloaded forms completely and bring them to class. Doing so in advance will save you considerable time the morning of class. There are seven (7) forms for you to complete and **bring to class**:

- Student Contract: Complete sections 1 & 2 and sign section 4. CCSD will complete section 3.
- Student Assessment: Answer all questions to help the instructor develop your training plan.
- Instructor Training Log: Add your name, email address, cell phone, and your street address.
- Class D Training Log: Add your name, permit license number and date of birth.
- School Attendance Form: Complete section 1. CCSD will complete section 2 after your second lesson.
- **Driver Certificate:** Add your name (top blank Line) and CCSD will sign and date after your last lesson.
- Student Instructions: Nothing to complete. Explains process for the road test and obtaining license from DMV.

Class starts promptly at <u>8:30am</u> and ends at <u>4:30pm</u>. Please arrive no later than <u>8:15am</u> - earlier if you have not filled out the paperwork. If you arrive after class begins, you will be rescheduled for a later date.

For class, you simply need to bring a positive attitude. The class will be held at our office/classroom located close to the intersection of Dorchester Road & Old Trolley Road at 1915 Old Trolley Road, Unit B, Summerville, SC 29485.

Although your classroom instructor has a structured curriculum, they are very easy-going and work well with teens. We break for a 30-minute lunch at 12:00pm and since we assume responsibility for all youth under 18, you are not allowed to leave the premises. We provide pizza and drinks at no charge or you can bring a lunch and place it in our office refrigerator.

After class, you will be given the name and phone number of your instructor. You will be able to call him or her in the middle of the week following your classroom instruction to schedule your lessons.

We have had students whose first time behind the wheel was with us. However, we suggest that you not begin our training until you are competent in handling the car and no longer afraid to be on the road with others. Otherwise, we are limited as to how much we can accomplish. We prefer to schedule the first (1st) lesson soon after this point and the last lesson just prior to the student taking the Road Test. The second lesson will be based on your instructor's evaluation and recommendation.



You've started South Carolina's driver training program and we thank you for choosing Cruise Control Driving School for your instruction. It is important to remember that you must have your beginner's permit for 180 days before you are eligible to take the road test. We hope the following information helps:

- 1. Two important documents were included in your forms download.
 - "Driver Training Certificate" will be filled out and signed at the completion of lessons. You can mail or fax this certificate to your insurance company to receive a discount on your premiums
 - If you are under 17 years old, a "Certification of School Attendance, (PDLA form) is provided and must be presented to the DMV when you go for your license.
 - ✓ First section is completed by student (applicant)
 - ✓ Part 1 is completed by Cruise Control
 - ✓ Part 2 is completed by school. Homeschool requirements differ, please read carefully.
 - ✓ Part 3 is completed by parent/guardian
- 2. If you take the road test with Cruise Control in our vehicle.
 - Coordinate with your instructor to schedule a road test at our office. During heavy test times, appointments can take more than one (1) week to schedule.
 - Please be on time! Late arrivals could lose their scheduled appointment time.
 - If you pass your road test you will receive a sealed "Green Envelope" for the DMV to get your license. DO NOT OPEN this envelope, it <u>voids</u> the Cruise Control road test.
- 3. If you take the road test with DMV.
 - Take proof of insurance and vehicle registration for the car you will be driving for the road test.
 - Be familiar with the vehicle you will be driving for the road test.
 - The examiner will perform a check of the vehicle including but not limited to headlights, turn signals, hazard lights, wipers, and brake lights for proper operation before beginning the test.
- 4. Additional document required by the DMV after passing the Road Test to process your license.
 - Sealed "Green Envelope" (only if you took your road test with Cruise Control)
 - If student is under 17, a completed "Certificate of School Attendance..." form (see above)
 - If student is under 18, the DMV has an additional Parental/Guardian form to complete
 - Student's valid beginner's permit and \$25 license fee
